

**Lady Luck HQ New Member Promotion  
WinStar World Casino and Resort**

**Official Rules**

1. WinStar World Casino and Resort is a governmental enterprise of The Chickasaw Nation (“Nation”), a federally recognized sovereign Indian tribe. Saturday, May 16, 2026, new patrons will be able to participate in our Lady Luck HQ New Member promotion to participate in Lady Luck HQ Meet & Greet.
2. Patrons must be 18 years of age or older with a valid photo ID and must be a member of WinStar Club Passport with complete and accurate information to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of WinStar World Casino and Resort are prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who is currently barred from any of the Nation’s Gaming Facilities; or any Promotional Sponsors.
3. Beginning Saturday, May 16, 2026, at approximately 8:00am (CST) through 6:00pm on Saturday, May 16, 2026; All New Members, who have never been a member of WinStar Club Passport, upon signup will receive the following offers, *which are only valid on the day of signup*:
  - a. Earn one (1) point to receive \$15 Reward Play.
  - b. Earn an additional twenty-five (25) points for a total of (26) points to receive an additional \$15 Reward Play.
  - c. Earn an additional fifty (50) points for a total of seventy-six (76) points and receive an additional \$20 Reward Play.

Any such decision shall be final and binding on all Patrons. In addition, the Chickasaw Nation reserves the right to void any entry, and/or change, cancel, or modify this promotion at any time without notice. Upon any prize dispute resulting from gameplay, participants may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

9. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification from the promotion and a forfeiture of any prizes.
